INTRODUCTION

The National Rodeo Association Limited (NRA) is a registered Australian non-profit company. Previously known as the Southeast Queensland Rodeo Riders Association, the NRA was established in 1966 with a view to meeting the needs of cowboys and cowgirls who were unable to travel and compete on a full-time basis due to family or work commitments.

The NRA is the governing body with which many Rodeo Committees throughout Southeast Queensland and Northern New South Wales affiliate with to run their rodeo events. The NRA provides standard rules for the operation of rodeos and the conduct of all members and personnel. In addition, the NRA provides various administrative and insurance services to affiliating Committees.

Animal welfare is of extreme importance to the NRA which has led to the adoption of the Animal Welfare Code of Conduct into the Association's rule book. The Code provides standards and guidelines that must be adhered to by members, competitors, and stock contractors alike to ensure the protection of all stock at rodeos.

Rodeo Queen, Fundraiser Queen, Rodeo Princess, and Junior Rodeo Princess

The role of a Rodeo Queen and Fundraiser Queen can be likened to that of a good will ambassador or public relations officer. Essentially, Our Rodeo Queen and Fundraiser Queen is the interface between Rodeo personnel and the general public.

The major duties of a Rodeo Queen and Fundraiser Queen are to promote rodeo, uphold and improve the image of the sport and to organise and appear in grand entry. A rodeo grand entry is the introduction of rodeo officials and representatives of each event to the crowds together with a procession of flag bearers on horseback including the Rodeo Queen, Fundraiser Queen, Rodeo Princess, and Junior Rodeo Princess. It is during the grand entry that the national anthem is sung.

The role of a Rodeo Princess and Junior Rodeo Princess is similar to that of a Rodeo Queen and Fundraiser Queen however, responsibilities are decreased somewhat due to the age of the title holders.

Contestants will be judged on five categories – appearance, knowledge, horsemanship, personality, and fundraising/community spirit. To be successful, entrants must demonstrate a sound knowledge of the sport and the Association, be a confident and capable rider, take pride in the appearance of both them and their horse, be confident, approachable, and friendly and demonstrate community spirit.

Rodeo Queen, Princess and Junior Princess Quests are held at various all-round rodeos throughout the rodeo season. Entrants are required to participate at a minimum of two quests during the year to be eligible to be crowned Rodeo Queen, Fundraiser Queen, Rodeo Princess, or Junior Rodeo Princess for the following rodeo year. Judging of the crowning quest takes place during the National Finals Rodeo (NFR) weekend and the crowning of the titleholders will be conducted as a presentation during the NFR each year.

QUESTING GUIDELINES

These guidelines will apply to all entrants wishing to run for the title of Rodeo Queen, Fundraiser Queen, Rodeo Princess, or Junior Rodeo Princess.

The Crowning Quest:

Judging of the quest to crown the titleholders will take place at the NFR. The exact times, dates and information for judging will be finalised once all details of the National Rodeo Association Finals have been agreed upon by the Board of Directors. All entrants will be notified of all relevant dates and times and any changes as soon as possible.

Qualifications:

Any female may compete in Rodeo Queen, Princess, and Junior Princess Quest. However, to be eligible to be crowned as Rodeo Queen, Fundraiser Queen, Rodeo Princess or Junior Rodeo Princess, entrants must:

- be current financial members of the NRA for the rodeo season (associate membership is acceptable),
- for Junior Rodeo Princess:
 - be 12 or under as of 1 January; and
 - raise a minimum of \$100,
- for Rodeo Princess:
 - be 17 or under as of 1 January; and
 - raise a minimum of \$500,
- for Rodeo Queen:
 - be 18 years or over as of 1 January; and
 - raise a minimum of \$500,
 - Entrants who raise above \$1500 will automatically qualify for the title of Fundraiser Queen.
- compete in a minimum of two NRA quests throughout the current rodeo season,
- submit their nomination form together with the entry fee by the closing date,
- and submit payment of their minimum fundraising amount by the closing date.

Royalty Nominations:

The nomination form for the Rodeo Queen, Fundraiser Queen, Rodeo Princess and Junior Rodeo Princess Quest is attached to this handbook.

The closing date for 2024 royalty nominations is Friday the 1st of November 2024 at 3:00pm. Nominations must be submitted to the NRA office by the closing date, this must be done using the nomination form and must be accompanied by the entry fee. The entry fee is \$25 (*payable in addition to the minimum fundraising amount*).

Fundraising:

Once entrants have nominated, they will be provided with a reconciliation report. Reconciliation reports must be used by entrants to records all funds raised. **Reports and funds raised that month must be banked into the NRA bank account and the form submitted to the NRA office at the end of each month.** A tally of all funds raised by each entrant will be kept by the NRA Office.

The minimum amount must be paid no later than the closing date of 1st of November 2024. Additional funds may be continued to be raised after submission of the minimum amount but must be paid no later than 3pm on Friday 22nd November 2024 to be added to the entrant's total fundraising tally.

JUDGING

Judges:

The judging of knowledge, appearance, horsemanship, personality, and fundraising/community spirit categories will be conducted by a panel of five or more judges. At least two judges will be individuals that are not current NRA members and do not regularly attend rodeos. Each judge will award a score out of 10 for each category and appearance will be judged out of 20 – 10 for personal appearance and 10 for appearance of the mount and tack.

Judging Scores:

○ Knowledge	– 10
○ Personality	– 10
○ Fundraising/Community Spirit	– 10
○ Horsemanship	– 10
○ Appearance	– 20
○ Knowledge Written Test	– 40
<u>Total score total of</u>	<u>100.</u>

Entrants will not be notified of the individuals on the panel of judges. The judges' decisions will be final.

JUDGING CATEGORIES

Interview:

The knowledge, personality and fundraising / community spirit categories will be judged by way of an interview to be conducted by the panel of judges. All entrants will be **required** to wear **black jeans and a white shirt** for interviews.

Entrants will be tested on their ability to interact, converse, and convey their opinion. The interview may include questions relating to rodeo, current events, and other social issues.

Funds raised will be tallied and advised to the panel of judges.

Entrants will be interviewed on their fundraising methods and questioned as to their community involvement (e.g., charity work, volunteer work etc) during the current rodeo season. Work undertaken within rodeo will also be considered by the judges.

Knowledge:

Entrants will be tested on their knowledge of the sport of rodeo, the National Rodeo Association, animal welfare code and public relations.

- Please remember to read the National Rodeo Association rule book and the QLD Animal Welfare Standards and Guidelines. These documents are accessible on the NRA website.

An entrant should have sufficient knowledge to be able to discuss rodeo, animal welfare and equine knowledge with members of the public. As the role of Rodeo Queen, Fundraiser Queen, Rodeo Princess and Junior Rodeo Princess includes promoting the sport of rodeo, title holders should be able to succinctly explain general rules and concepts relevant to the sport. A solid understanding of current events should also be demonstrated to ensure that entrants and title holders are able to interact and converse with members of the public.

At no time should an entrant or title holder provide a personal opinion in relation to the NRA, the NRA board or animal welfare issues. Any enquiries in relation to these matters should be directed to a board member.

Personality:

Entrants should display a happy, confident and approachable attitude. Entrants and title holders alike should be able to interact with members of the public and portray an inviting personality. Entrants should demonstrate high moral standards and integrity.

To assess the entrants' personalities, entrants will partake in an interview with the panel of judges. The interview will include questions about the entrant, their rodeo experience and understanding and their view on various social issues.

Fundraising/Community Spirit:

Participation in additional charitable and community activities are not compulsory but will be considered by the judges.

In addition to meeting their minimum fundraising requirements, entrants could consider partaking in the following:

- Raising funds above the minimum required,
- Assisting the Rodeo Queen with grand entries,
- Assisting with junior rodeos and where possible with open rodeos,
- Assisting with the organising of raffles (with prior approval of the NRA Office),
- Volunteering at institutions such as animal shelters, hospitals, retirement homes etc.,
- Assisting with any NRA functions throughout the season.

Appearance:

Entrants will be judged for their appearance during the horsemanship component. The personal appearance of the entrant and appearance of the entrant's mount and tack.

Personal Appearance – Entrants may wear attire of their own choosing for horsemanship provided that it complies with all applicable NRA regulations. No matter what type or style of outfit an entrant wears, all attire should be clean, pressed and well fitting.

The following are points to remember:

- Hats should be clean, well-shaped and well fitted to not hide the entrant's face,
- Boots should be clean with no scuff marks,
- Consider the lighting of various venues when selecting attire colours,
- Excessively tight or baggy clothing is undesirable,
- Sheer or revealing outfits are undesirable,
- Facial piercings are undesirable,
- Multiple sets of earrings are undesirable,
- Visible tattoos are undesirable,
- Chaps are not permitted.

Appearance of Mount and Tack – Above all, horses and tack should be clean.

Points will not be awarded based on the value or age of horses or tack. Points will be awarded based on the presentation, cleanliness, fit and appropriate use of horses and their tack.

The following are points to remember:

- Horses should appear in good health, have a well-groomed coat and display good hoof care,
- White socks should be white (appropriate allowances will be made for discolouration caused by arena conditions),
- Tack should be well fitted for both horse and rider and be appropriate for its use,
- Protective boots and wraps may be worn but are not necessary, provided they match and add value to the appearance of the outfit.

Horsemanship:

Horsemanship will be tested by way of a ridden pattern to be conducted in the arena.

Entrants will be tested on their ability to control their mount and to project themselves from horseback. Rodeo Queen and Princess entrants will also be provided with the opportunity to display their ability to carry a flag during the flag carrying section. If the entrant or the entrant's mount is not capable of safely carrying a flag, the entrant must not attempt to do so. If the entrant opts not to carry a flag, they can still participate in the flag carrying section by executing the royalty wave.

The entrant will be judged based on having the horse under full control at all times. Horses should be free moving, well broken and responsive to the aids of the entrant. Entrants should demonstrate a solid understanding of horsemanship skills and the ability to follow directions by completing the required horsemanship pattern.

During the judging of the horsemanship component, all Rodeo Princess and Junior Rodeo Princess entrants must wear an approved helmet. Any Rodeo Queen entrants who are not 18 years of age at the time of judging must wear an approved helmet. Remaining entrants may compete in a helmet or western hat. You will not lose any points for this.

Knowledge Written Test:

Knowledge will be tested by way of a written exam with entrants will be awarded a score out of 40. All entrants will sit their exam as a group (e.g. all Rodeo Princess will be tested at one time). Any entrant found cheating will be disqualified from the Quest.

It is expected that all entrants should have a thorough understanding of the following matters:

- NRA Rule Book
- Animal welfare guidelines (both in NRA rules and the '*Queensland Animal Welfare Standards and Guidelines – Animals at Rodeos*' document)
- NRA history
- General rodeo knowledge
- Equine anatomical and general health matters
- Western tack and apparatus
- Other matters relevant to the sport of rodeo

The level of understanding expected of each entrant will be determined by the relevant royalty category. This will be reflected with three written tests to suit each royalty category.

Tally of Points:

After the completion of the final sections of judging, the NRA Office Manager and two judges from the panel of judges will tally and verify all scores.

In the event of a tie, the horsemanship score will be used to determine a winner. If there is still a tie, entrants appearance scores will then be used followed by knowledge and personality.

GENERAL REQUIREMENTS FOR ENTRANTS

- Entrants must abide by all NRA rules at all times, no exceptions.
- Entrants must abide by all NRA rules and requirements listed in this handbook at all times, no exceptions.
- Entrants must wear their sash at all fundraising activities. Sashes should not be worn during rodeo competition.
- Entrants should not be seen smoking in public.
- Entrants must abide by the NRA drug and alcohol policy and not consume alcohol whilst wearing the NRA entrant sash.
- Entrants must not exhibit undesirable behaviour such as yelling, swearing, or arguing.
- Entrants must not make derogatory statements by any means, including social media.
- Entrants must not offer personal opinions in relation to the NRA, the NRA board, decisions or rules of the NRA or animal welfare issues.
- Entrants must be dressed in appropriate western attire during all quest promotional and fundraising activities.
- Entrants are expected to attend all rounds of the NRA finals and provide assistance as required by the Rodeo Queen.

Entrants found to have breached these requirements will have their nomination rejected and entry fee forfeited.

QUEST AWARDS

The following category winners will be awarded at the completion of the Quest:

Rodeo Queen

- Runner Up Rodeo Queen
- Fundraiser Queen
- Rodeo Queen

Rodeo Princess

- Runner Up Rodeo Princess
- Rodeo Princess

Rodeo Junior Princess

- Runner Up Junior Rodeo Princess
- Junior Rodeo Princess

Subject to entrant numbers in the rodeo queen category, additional awards may be presented such as:

- Miss Horsemanship
- Miss Appearance
- Miss Personality
- Miss Knowledge

Awards will be finalised and notified to all entrants following the closing date.

Prizes:

The Rodeo Queen, Fundraiser Queen, Rodeo Princess, and Junior Rodeo Princess will each receive a trophy buckle. If there is a minimum of three Queen entrants, all raising the minimum fundraising amount of \$1500 each, then the winner of the Rodeo Queen title will receive a trophy saddle as a part of her prize.

TITLE HOLDER RULES AND RESPONSIBILITIES

All title holders must fulfil their responsibilities throughout their reign and comply with the rules set out below. Any title holder who fails to comply with these requirements will forfeit their title. The relevant title holders' role will then be carried out by the runner-up.

Rodeo Queen

Responsibilities:

- To actively promote the NRA, NRA rodeos throughout the reigning season along with liaising with the NRA Office Manager, Fundraiser Queen, Rodeo Princess and Junior Rodeo Princess to organise promotional activities.
- Contacting rodeo committees, introducing yourself as Rodeo Queen and offering to assistance with any promotional needs and organising the Local Rodeo Queen and Princess Quest, for example: judges, sashes and/or prizes. Note: The Rodeo Committee should provide the quest sashes if they opted for a quest, some may select to provide an additional prize, however this is optional – Gently communicate this with the committees. Also offer the committee the option of providing one judge for the quest.
- To care for the NRA Rodeo Queen crown, chaps and grand entry flags and transporting the flags as required to Rodeos along with wearing the chaps in grand entries only.
- To organise and coordinate the Grand Entry as required at NRA All Round and Super All-Round Rodeos. If the Rodeo Queen cannot be present at these rodeos, the Rodeo Queen must advise the NRA Office and organise the Fundraiser Queen. When the Fundraiser Queen is unable to organise the Grand Entry then the Rodeo Princess or a suitable NRA member should be tasked with conducting the Grand Entry. Draws are uploaded after 12pm Wednesday to assist organising the grand entry list. Rodeo Queen to supply the grand entry list by Thursday to allow it to be advertised with the draws. We encourage having a Grand Entry at any NRA affiliated Rodeos.
- To present herself and her horse to a standard expected of a Rodeo Queen at all times.
- To provide an end of year report to the office for inclusion of the NRA Sports News.
- To promote the Rodeo Queen and Princess Quest.
- To encourage and assist Rodeo Queen and Princess Quest entrants.
- To organise the Rodeo Queen, Rodeo Princess, and Junior Rodeo Princess Quest with the Fundraiser Queen and NRA Office Manager.
- To seek sponsorship for the prizes for the end of year Quest. (This is optional) Prizes are an option for end of year not compulsory.
- **To pack down Presentation Night the year she is crowned and organise the Presentation night the year she hands over her title (with the help of the Office and Royalty). – N.B this is a requirement. You must contact the office to begin planning around October.**
- To work with and assist the NRA office Manager when required.

Local Rodeo Quests:

- To organise judges for the local Rodeo Quests – *Rodeo Queen cannot judge the quest or give any input to judges.*
- Only a sash and one prize (prize is optional) to be awarded for each title of Queen, Princess and Junior Princess.
- Horsemanship pattern to be kept minimal (e.g., one large circle, finishing with a figure 8 and stop). No flags used in workout.

- Appearance of mount and tack to be judged with appropriate allowances that considers the conditions of arena, weather and competition.
- Questions must be kept basic – *no technical questions*.

Fundraiser Queen

Responsibilities:

- To actively promote the NRA, NRA rodeos throughout the reigning season along with liaising with Rodeo Queen, NRA office manager, Princess, and Junior Princess to organise fundraising activities.
- To care for the NRA Fundraiser Crown.
- To assist the Rodeo Queen with organisation of Grand Entries. If the Rodeo Queen cannot be present at the Rodeo, the Fundraiser Queen will conduct the Grand Entry and will carry the Australian Flag in the Rodeo Queen's place.
- To present herself and her horse to a standard expected of a Rodeo Royalty at all times.
- To assist the Rodeo Queen with organisation of Quests at rodeos throughout the rodeo season where required by the Rodeo Queen.
- To promote the Quest.
- To encourage and assist Quest entrants.
- To organise the Rodeo Queen, Rodeo Princess, and Junior Rodeo Princess Quest with the Rodeo Queen and NRA office Manager.
- To seek sponsorship for the prizes for the end of year Quest. (This is optional) Prizes are an option for end of year not compulsory.
- **To pack down Presentation Night the year she is crowned and organise the Presentation night the year she hands over her title (with the help of the Office and Royalty). – N.B this is a requirement. You must contact the office to begin planning around October.**
- To work with and assist the NRA office manager when required.

Rules for Rodeo Queen and Fundraising Queen:

- Should not be seen smoking in public and must abide by the NRA drug and alcohol policy, and not consume alcohol whilst wearing the NRA Crown.
- Must abide by all NRA rules at all times, no exception.
- Must wear the NRA Crown at all NRA rodeos and functions (except when competing).
- Must not compete in any Quests during her reign or the 12 months following her reign.
- Must not exhibit undesirable behaviour such as yelling, swearing, or arguing.
- Derogatory statements must not be made by any means, including social media.
- Must not offer personal opinions in relation to the NRA, the NRA board, decisions or rules of the NRA or animal welfare issues.
- Must be dressed in appropriate western attire during all Quest promotional and fundraising activities.

Rodeo Princess and Junior Rodeo Princess

Responsibilities:

- To promote the NRA, and the sport of rodeo.
- To care for the NRA Rodeo Princess / Junior Rodeo Princess Crown and chaps
- To assist the Rodeo Queen / Fundraising Queen in carrying out their duties.
- To encourage and assist Quest entrants.
- To present herself and her horse to a standard expected of a Rodeo Princess / Junior Rodeo princess at all times.

Rules:

- Must abide by all NRA rules always, no exceptions.
- Must wear the NRA Rodeo Princess Crown at all NRA rodeos and functions (except when competing).
- Should wear the NRA Rodeo Princess / Junior Rodeo Princess chaps during all Grand Entries only.
- Must not compete in the following season NRA Rodeo Princess / Junior Princess Quest.
- Must not exhibit undesirable behaviour such as yelling, swearing, or arguing.
- Derogatory statements must not be made by any means, including Facebook.
- Must not offer personal opinions in relation to the NRA, the NRA board, decisions or rules of the NRA or animal welfare issues.
- Must be dressed in appropriate western attire during all Quest promotional and fundraising activities.

NRA Office Manager

Responsibilities:

- To supervise the title holders to ensure all responsibilities are being fulfilled and rules complied with.
- To address any concerns of entrants, parents, and members in relation to the Quest and resolve conflicts effectively.
- To bring to the attention of the NRA board any issues that cannot be appropriately resolved in relation to the Quest or the title holders.
- To update and ensure compliance with the Quest Handbook.
- To reconcile all funds received on account of the Quest.
- To approve all financial transactions.
- Oversee all NRA titleholder's management duties.
- To play an active role providing support and assistance.
